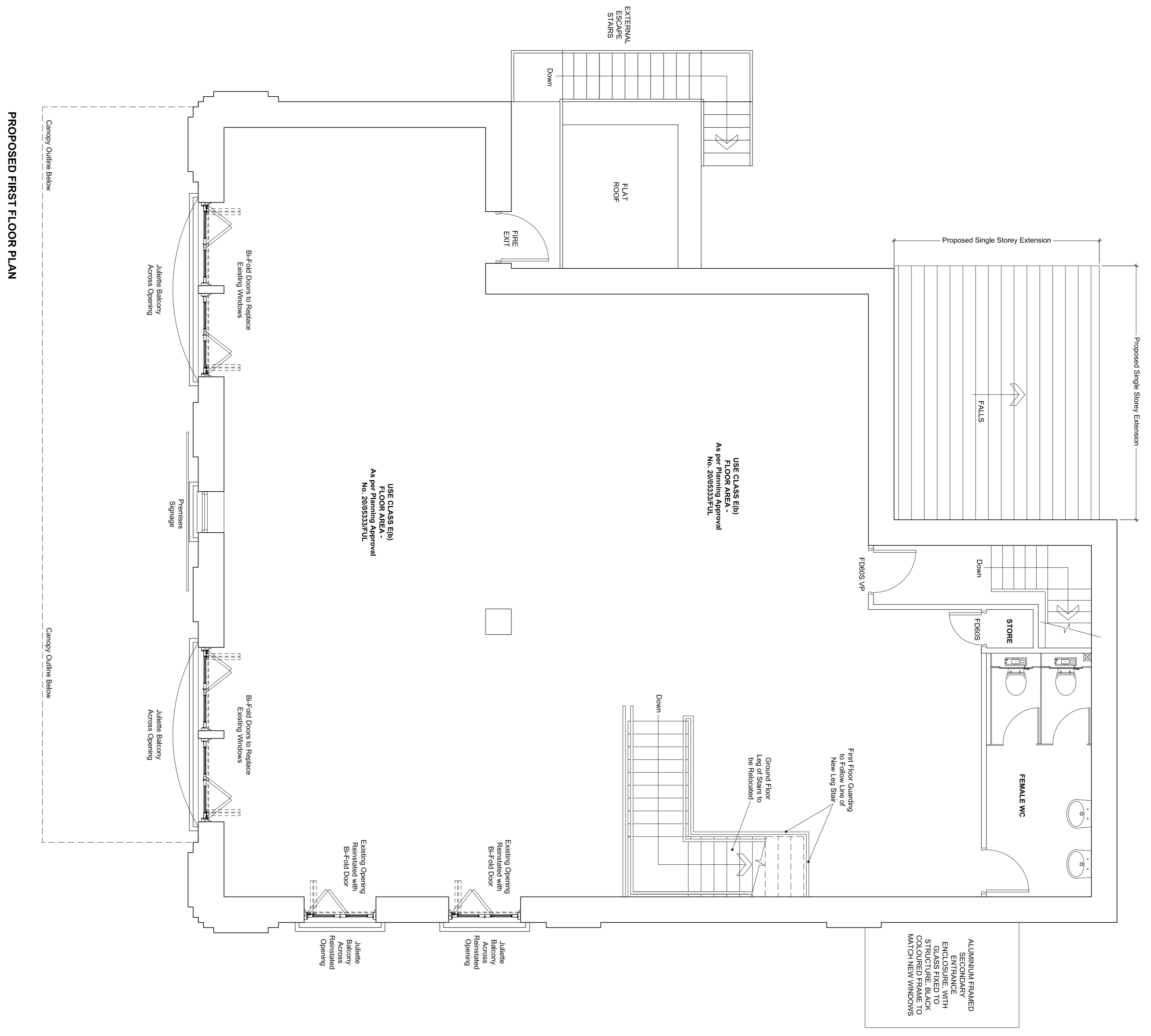
All Landscaping, Structural, Mechanical & Electrical Information are indicative only at this stage, subject to detailed design information from Consultants.

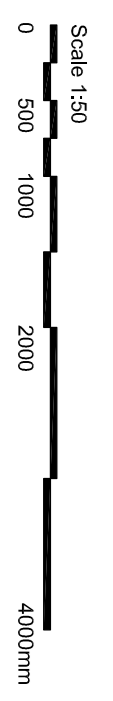
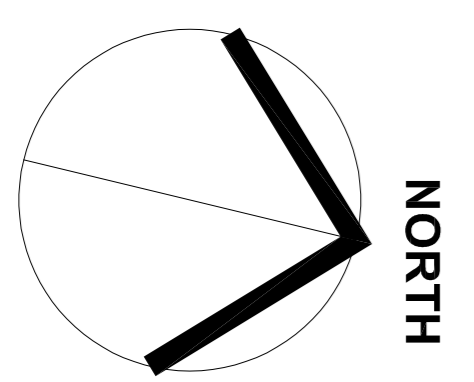
The Construction Design and Management Regulations 2015:-
